### Who We Are

The U.S. Department of Justice (DOJ) Bureau of Justice Assistance (BJA) National Training and Technical Assistance Center (NTTAC) facilitates the delivery of high-quality, strategically focused training and technical assistance (TTA) by connecting state, local, and tribal justice agencies with national experts to help address communities' unique needs. BJA NTTAC supports justice agencies ranging from prosecutors' offices, to police departments, to city and county commissioners, to corrections departments. Our goal is to provide these agencies with the TTA resources needed to reduce crime, achieve safer communities, and promote a fair criminal justice system.

#### What We Do

BJA NTTAC provides no-cost TTA in-person and virtually on a wide range of criminal justice topics, including adjudication, corrections, crime prevention, justice information sharing, law enforcement, mental health, substance abuse, violence reduction, and tribal justice. Services may involve assistance implementing programs and strategies, curriculum development, data analysis, classroom and virtual training, peer-to-peer visits, research and information, and strategic planning.

#### **Additional Services We Offer**

In addition to our specialized TTA services, BJA NTTAC offers resources, tools, and other services that have been developed to address emerging issues and key trends in the criminal justice technical assistance field. These services, available to the criminal justice community, include:

- On-Demand TTA Programs BJA NTTAC has developed teams of consultants who can quickly respond to TTA requests by identifying gaps and needs and providing recommendations in specific topical areas, including:
  - **Crime Analysis on Demand** Enhances an agency's ability to analyze and use data to make informed decisions, respond effectively, and prevent crime.
  - Prosecution Assessments Assesses the capacity of prosecutors' offices to prosecute violent crime and identifies the strengths, gaps, and adjustments needed to enhance results.
  - Technology Assessments Assesses an agency's technical resources and abilities, and provides actionable recommendations to enhance their technology-driven initiatives and train personnel.
- Violence Reduction Response Center (VRRC) Established under the direction of the Attorney General, VRRC seeks to connect state, local, and tribal justice agencies with violent crime reduction TTA resources offered by DOJ. By providing direct referrals to DOJ crime reduction publications, grant opportunities, and TTA, VRRC serves as a one-stop shop to connect individuals to the most appropriate resources available.
