Introduction

The Center for Court Innovation seeks to help create a more effective and humane justice system by designing and implementing operating programs, performing original research, and providing reformers around the world with the tools they need to launch new strategies.

Operating Programs

The Center conceives, plans, and operates programs that seek to test new ideas, solve difficult problems, and achieve system change. Our projects include community-based violence prevention projects, alternatives to incarceration, reentry initiatives, and court-based programs that reduce the use of unnecessary incarceration and promote positive individual and family change. Some of our projects are big, serving thousands of people each year. And some are small, working intensively with a few dozen people at a time. No matter the size or the topic, our approach is always the same: thoughtful planning, an emphasis on creativity, and the rigorous use of data to document results. Our efforts have produced tangible results like safer streets, reduced incarceration, and improved neighborhood perceptions of justice.

Key to our work is the idea of collaboration. To get things done, we partner with a broad range of government, nonprofit, and community agencies. We have a strong relationship with government in New York—especially the state court system, for which we provide ongoing strategic advice and programming.

Research

Researchers at the Center conduct independent evaluations, documenting how government systems work, how neighborhoods function, and how reform efforts change things. We have performed multiple randomized controlled trials. Our researchers have been published in numerous peer-reviewed journals. And we have published much-cited studies that have looked at such topics as youth in the sex trade, reentry court, and drug treatment as an alternative to incarceration. We believe in the “action research” model; accordingly, our researchers provide regular feedback on the results of the Center’s own operating programs. The Center disseminates information about justice reform through books and other publications, videos, podcasts, social media (including Facebook and Twitter), and other vehicles.

Expert Assistance

The Center for Court Innovation provides hands-on, expert assistance to reformers around the world, including judges, attorneys, justice officials, community organizations, and others. Having launched dozens of innovative justice initiatives, we know firsthand the nuts and bolts of how to get a new project off the ground. Experts from the Center for Court Innovation are available to help plan, implement, and evaluate new policies, practices, and technologies. Our assistance takes many forms, including help with analyzing data, facilitating planning sessions, and hosting site visits to our operating programs in the New York City area.

The Crime and Justice Institute (CJI) is a division of Community Resources for Justice (CRJ). CRJ's mission is to change lives and strengthen communities by advancing policy and delivering individualized services that promote safety, justice, and inclusion. CRJ has two divisions in addition to CJI: Social Justice Services, which provides residential and non-residential services for men and women leaving incarceration, and for young adults with complex clinical needs; and Community Strategies, which supports adults with developmental disabilities to live as independently as possible in the community.

Concerns of Police Survivors Inc.

C.O.P.S.

Each year, between 140 and 160 officers are killed in the line of duty, and their families and coworkers are left to cope with the tragic loss. Concerns of Police Survivors, Inc. (C.O.P.S.) provides resources to help them rebuild their shattered lives. There is no membership fee to join C.O.P.S., for the price paid is already too high.

C.O.P.S. was organized in 1984 with 110 individual members. Today, C.O.P.S. membership includes more than 37,000 survivors. Survivors include spouses, children, parents, siblings, significant others, and affected coworkers of officers killed in the line of duty according to federal government criteria. C.O.P.S. is governed by a national board comprised of law enforcement survivors. All programs and services are administered by the National Office in Camdenton, Missouri. C.O.P.S. has more than 50 chapters nationwide that work with survivors at the grassroots level.

C.O.P.S. programs for survivors include the National Police Survivors' Conference, held each May during National Police Week; scholarships; peer support at the national, state, and local levels; the "C.O.P.S. Kids" counseling reimbursement program, "C.O.P.S. Kids" Summer Camp, and "C.O.P.S. Teens" Outward Bound experience for young adults; special retreats for spouses, parents, siblings, adult children, extended family, and coworkers; trial and parole support; and other assistance programs.

C.O.P.S. knows that a survivor's level of distress is directly affected by the agency's response to the tragedy. C.O.P.S., therefore, offers training and assistance to law enforcement agencies nationwide on how to respond to the tragic loss of a member of the law enforcement profession. C.O.P.S. is a 501(c)(3) nonprofit organization. C.O.P.S. programs and services are funded by grants and donations.
